

**myTalk 107.1 – App Exclusive Reward Cash & Cruise Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

- 1. Eligibility:** The myTalk 107.1 App Exclusive Reward Cash & Cruise Sweepstakes (the "Sweepstakes") is open only to individuals who are 18 years or older and residents of Minnesota or Wisconsin and who reside within 150 miles of myTalk 107.1's studio located at 3415 University Avenue, St. Paul, MN 55114, to be eligible to win. - 2. Sweepstakes Period:** The Sweepstakes begins on April 1, 2019, at or about 12:00:01 AM Central Time ("CT") and ends on April 30, 2019 at or about 11:59:59 PM CT (the "Sweepstakes Period").

How to Enter:** To enter, you must download the myTalk 107.1 mobile Stream Player app from your App marketplace to your iPhone, iPad or Android device, and open the app on your smartphone or iPad. Then, each day during the Sweepstakes Period, upon opening the app, you will find entry form asking for your name, email address, date of birth, address, and daytime telephone number. Once you have completed the entry form, click "submit" to be entered into the Random Drawings. Limit one (1) entry per person/email address during the sweepstakes period. All entries must be received by 11:59:59 p.m. CT on April 30, 2019 to be entered into the Random Drawings.
- 4. Random Drawings:** Starting on April 1, 2019 and ending on April 30th, 2019, there will be a random drawing held each weekday during the Sweepstakes Period (each, a "Weekday Drawing"), to be conducted from among all eligible entries received up until the day before each Weekday Drawing, to select one (1) Weekday Winner who will win one (1) Daily Prize.
