

myTalk 107.1 - STATE FAIR PATIO SET GIVEAWAY

OFFICIAL RULES

1. HOW TO ENTER: NO PURCHASE NECESSARY. There are two ways to participate in this sweepstakes.

Minnesota State Fair Entries. In order to participate via this method, stop at the myTalk 107.1 booth at the Minnesota State Fair during normal Minnesota State Fair hours from 9:00 a.m. on Thursday, August 22, 2019, through 8:00 p.m. on Monday, September 2, 2019, and complete the entry form. (Please note that the myTalk 107.1 booth is open from 9:00 a.m. to 8:00 p.m. daily during the Minnesota State Fair.)

Email Entries. Entries will be accepted from 9:00 a.m. on Thursday, August 22, 2019, through 8:00 p.m. on Monday, September 2, 2019. myTalk 107.1 is not responsible for problems sending your entry, or technical or atmospheric conditions that disrupt the completion of the entry, undelivered emails, or any other problems which might or might not result from this sweepstakes.
